SIGNS YOU MAY BE UNDER INVESTIGATION

Investigations can manifest through subtle or overt indicators. Recognizing these signs could help you determine whether law enforcement has you in their sights.

SUBTLE SIGNS OF SURVEILLANCE

1. Unfamiliar Vehicles

Repeatedly seeing unknown cars near your home or workplace can be an indication of police surveillance. Investigators often use unmarked vehicles to monitor suspects discreetly.

OVERT SIGNS OF INVESTIGATION

While subtle clues require interpretation, overt actions by law enforcement leave little doubt that you're being investigated:

1. Direct Contact with Police

Law enforcement may reach out to question you, but they are not obligated to disclose the nature of their interest. If the police request a meeting, bring you in for questioning, or otherwise engage with you, it's wise to assume you're being investigated.

2. Questioning of Your Associates

If acquaintances or colleagues report being questioned about you, this is a strong indicator that you're a focus of interest. Investigators often build cases by speaking to those in a suspect's social or professional circles.

3. ISP Subpoena Notification

If your internet service provider informs you of a subpoena regarding your online activities, it may indicate law enforcement is collecting digital evidence as part of their investigation.

4. Frozen Financial Accounts

When bank accounts or credit cards are frozen without clear explanation, it often suggests a legal authority has restricted access, typically as part of an ongoing investigation.

WHAT TO DO IF YOU SUSPECT YOU'RE BEING INVESTIGATED

If you observe one or more signs that suggest you're under police investigation, the following steps can help safeguard your rights:

Consult an Attorney Immediately

Review your social media activity and privacy settings. Be mindful of what you share publicly, as this could be used as evidence in an investigation.

5. Document Suspicious Activity

Keep a record of unusual events, such as strange vehicles, social dynamics, or financial irregularities. This information could prove useful to your attorney.
