NOTABLE ALIEN ABDUCTION CASES FROM THE 20TH CENTURY:

- 1961 Betty and Barney Hill Abduction: On September 19, 1961, Betty and Barney Hill claimed to have been abducted by extraterrestrials while driving in rural New Hampshire. Their case received widespread media attention and is considered the first widely reported alien abduction.
- 1973 Pascagoula Abduction: On October 11, 1973, Charles Hickson and Calvin Parker claimed they were abducted by aliens while fishing near Pascagoula, Mississippi. Their case remains one of the most well-documented abduction cases.
- 1975 Travis Walton Abduction: On November 5, 1975, logger Travis Walton reported being abducted by a UFO while working in the Apache-Sitgreaves National Forest in Arizona. Walton's case gained significant media attention and was later adapted into the book and movie "Fire in the Sky."
- 1976 Allagash Abductions: In August 1976, four friends (Jim Weiner, Jack Weiner, Charles Foltz, and Charles Rak) claimed to have been abducted by extraterrestrials while on a camping trip in the Allagash Wilderness in Maine. All four men later underwent hypnotic regression and shared eerily similar accounts of the event.
- 1980 Cash-Landrum Incident: On December 29, 1980, Betty Cash, Vickie Landrum, and Vickie's seven-year-old grandson, Colby Landrum, reported encountering a UFO while driving near Huffman, Texas. The three experienced physical effects from the encounter, leading to a lawsuit against the U.S. government for damages.
- 1987 Whitley Strieber: In his 1987 book "Communion," author Whitley Strieber shared his experiences of alien abduction, including encounters with the now-iconic "grey aliens." Strieber's account helped popularize the idea of ongoing contact and abduction by extraterrestrial beings.
- 1991 Linda Napolitano Abduction: On November 30, 1991, Linda Napolitano (also known as Linda Cortile) claimed to have been abducted from her Manhattan apartment by extraterrestrials. The case gained notoriety due to alleged corroboration by independent witnesses who reported seeing the abduction take place.
- 1994 Ariel School Encounter: On September 16, 1994, over 60 schoolchildren in Ruwa, Zimbabwe, reported seeing a UFO and interacting with extraterrestrial beings during their morning recess. The case received worldwide attention and was documented by Pulitzer Prize-winning Harvard psychiatrist Dr. John Mack.

- LESSER-KNOWN BUT STILL INTRIGUING ALIEN ABDUCTION CASES FROM THE 20TH AND 21ST CENTURIES
- 1957 Antonio Vilas Boas Abduction: In October 1957, Brazilian farmer Antonio Vilas Boas claimed he was abducted by extraterrestrials while working in his fields. This case predates the Betty and Barney Hill abduction and is known for its detailed account of a human-extraterrestrial hybridization program.
- 1968 Robert Taylor Incident: On November 9, 1968, Scottish forestry worker Robert Taylor reported an encounter with a UFO and two smaller spherical objects in Dechmont Woods near Livingston, Scotland. This case is unique because it resulted in a criminal investigation due to the damage to Taylor's clothing and the physical evidence found at the scene.
- 1974 Robert Perala Abduction: On December 26, 1974, Robert Perala claimed he was abducted by extraterrestrials while driving home in the San Francisco Bay Area. Perala's account includes a description of a "lightbeing" and communication with advanced extraterrestrial beings.
- 1978 Frederick Valentich Disappearance: On October 21, 1978, Australian pilot Frederick Valentich disappeared during a flight over Bass Strait after reporting a UFO encounter. While not a confirmed abduction case, the circumstances surrounding Valentich's disappearance remain a mystery and have led some to speculate that he may have been taken by extraterrestrials.
- 1979 Robert and Frances Brown Abduction: In August 1979, Robert and Frances Brown of Stroudsburg, Pennsylvania, claimed they were abducted by extraterrestrials during a driving trip through New Jersey. Their case includes the description of a "telepathic communication" with their abductors.
- 1983 Alfred Burtoo Abduction: On August 12, 1983, British pensioner Alfred Burtoo claimed he was abducted by extraterrestrials while fishing along the Basingstoke Canal in England. Burtoo's case is unusual because the alleged extraterrestrials deemed him too old and returned him to Earth.
- 1993 Kelly Cahill Abduction: In August 1993, Australian woman Kelly Cahill claimed she was abducted by extraterrestrials while driving with her family in Victoria, Australia. Cahill's case is notable for its multiple witnesses, including other motorists who reported a similar UFO sighting that night.
- 2001 Peter Khoury Abduction: In July 2001, Australian man Peter Khoury claimed he was abducted by extraterrestrial beings and provided a sample of hair, which was later analyzed by DNA experts. The results were inconclusive but fueled speculation about the possibility of extraterrestrial-human hybridization.
